Our Fixed Fee Service

Our fixed fees typically start from £3,000 plus VAT. Most matters fall within the range of £3,000 to £7,500 plus VAT, depending on their complexity, the scope of work required, and any additional legal issues that arise. Exceptionally complex matters may attract higher fees, which will always be discussed and agreed with you before any additional chargeable work is undertaken.

The final fixed fee will depend on several factors, including:

- The complexity of your matter.
- The amount and nature of the documentation requiring review.
- The urgency of the work.
- Whether additional legal issues arise during the course of the matter.
- The extent of correspondence, negotiations, or meetings required.
- Whether expert evidence or third-party involvement is necessary.

Following your initial consultation, we will assess your matter and, wherever possible, provide you with a personalised fixed-fee quotation. Your quotation will clearly set out the work included within the agreed scope of our retainer.
